# 2016-2017 Scholarship Annual Report Prepared by Barbara W. Hughes

I am honored to have served as Chairman of the Woman's Club of Winter Park, Inc. Scholarship Committee for a third year. This year the following members served on the committee:

Barbara Bergstrom, Arlene Bridges, Marilyn Cromer, Beverly Cox, Sharyn Jontz, Patricia Johnson, Elaine Laegeler, Bonnie Mizell, Karen Rodda, and Diane Sandquist were returning members. Sharyn Jontz served as Secretary and Patricia Johnson served as Treasurer.

Our new members were Elaine Kerr and Sheila Spitler.

The Returning Committee met on August 15, 2016, to review the year, to refine the rubric utilized and to make adjustments to the Applications. The committee also made a recommendation to be taken to the Woman's Club Board regarding the Scholarship Investment Policy.

On November 2, 2016, The Board of Directors of The Woman's Club of Winter Park, Inc. amended the second paragraph of the Scholarship Committee Investment Policy. The second paragraph now reads: "Donors to the Scholarship Fund shall have the choice of placing their donation(s) in a capital fund in perpetuity with only income from these invested funds to be used for scholarships OR donors may choose to designate to have all or part of their donation(s) be utilized for scholarships in the current fiscal year. If no designation is indicated, then the donation(s) will automatically default to be placed in the capital fund in perpetuity and therefore only the income from these invested funds shall be utilized for scholarships."

We hosted a Scholarship Table for the Membership Tea on September 22nd.

Our first meeting with the returning and new committee members was on November 9. We looked at plans for the year ahead of us and we began in earnest to plan for the Scholarship Reception to be held on December 15<sup>th</sup>. On both December 14<sup>th</sup> and 15<sup>th</sup>, we were very busy decorating the Woman's Club and preparing food for the Scholars' Reception.

We had a very well attended Scholars' Reception on December 15<sup>th</sup>. Gift of Music entertained us and Dr. Robert Smither, Dean Emeritus Rollins College, College of Arts and Sciences, provided a thought-provoking talk on Leadership. A few of the student scholars also shared about their college experiences. We ended the evening with several Raffle winners - thanks to generous donations of members and others.

In January 2017, I prepared a report of last year's scholarships for the Central Florida Foundation. We receive earned income annually from the Pauline Mossman endowment housed at the Central Florida Foundation to utilize towards our scholarship awards.

Applications were due on March 1, 2017. On March 6, 2017, the committee met to study the applications of both new applicants and renewal applicants. The committee diligently examined the material received from each applicant and narrowed down the number to interview. Over fifty applications were received. The committee interviewed new applicants on April 1, 2017. The Renewals do not need to be interviewed again.

On April 3, 2017, the committee met to determine the actual scholarship awards for 2017-2018. We are proud to be awarding 15 Renewal Scholars in the amount of \$500 per scholar and 12 New Scholars in the amount of \$2,000 per scholar and 2 New Scholars in the amount of \$1,000 each. The total awards are \$33,500. The Committee hopes you will join us in December of 2017 to have the opportunity to meet The Woman's Club of Winter Park, Inc. outstanding Scholars at a reception held to honor them.

The moneys awarded to the students are derived from the income earned from the Pauline Mossman endowment at the Central Florida Foundation, the Morse Genius Foundation, the earnings from a capital fund at Morgan Stanley, and donations made specifically to be utilized for scholarships in the current fiscal year. The capital fund at Morgan Stanley has been built and sustained by members who have made donations over the

years or by bequests that have been made by members or their families and friends. We thank each and every one of you who have made our scholarships possible.

In July checks will be sent to the colleges and universities of our scholars.

Our committee met on April 10, 2017, to evaluate this year and to prepare for our upcoming year – perhaps with some new ideas!

It has indeed been an honor to serve with some amazingly dedicated woman over the past three years.




